Rules and Regulations

1. **NO SOLICITING!** The festival serves as a fundraiser for the Venango Area Chamber of Commerce. No other organizations are permitted to fundraise in order for the Chamber to recover the thousands of dollars spent to put on such a festival.
2. Sales of raffles, merchandise, memberships, or propaganda are **STRICTLY PROHIBITED!**
3. Food Vendor booths are open to area restaurants, delicatessens, caterers, and non-profit organizations. This event is an opportunity to advertise your business & also let potential customers sample your food. Similar food items are permitted at various booths, but vendors may be limited on offerings to allow a variety of food items available to the public (get your application in early to assure your food item choices).
4. Set-up / Tear Down: Set up can begin at 7 am. Booths must be ready by 11 am. **NO** early tear down unless you run out of food.
5. Exhibitors must furnish their own booths, tables, and/or tents, extension cords, napkins, plates, etc.
6. Business or organization signage for each booth is the responsibility of the exhibitor. Vendor must provide signage that lists the food item(s) and the cost.
7. Your sales tax license should be prominently displayed.
8. The Venango Area Chamber of Commerce and Cranberry Township, their owners, officers, agents or employees cannot be held responsible for bodily injury or property damage occurring as a result of vendor's participation in the Cranberry Festival. It is highly recommended that you carry Property and Public Liability Insurance.
9. **ANY VENDORS THAT DO NOT SHOW UP ON FESTIVAL DAY WILL NOT BE PERMITTED TO PARTICIPATE IN FUTURE YEARS.** Unless festival staff was made aware of the cancellation prior to Friday, September 6th. We understand that emergencies may arise, therefore, please call (814) 676-8521 to cancel your space.
